## Additional Notes

Membership runs for 12 months, starting at quarterly intervals from January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup> and October 1<sup>st</sup>.

For new members, there is an additional small entrance fee (non-refundable) to cover the application processing cost.

Similarly, for existing members applying to upgrade their category of membership, a transfer fee is charged to cover assessment and administration.

Applications for new membership must include the appropriate payment to be processed upon receipt. \*

## Other Fees:

### *Professional Standards Inspection*

If an applicant does not hold formal qualifications and is unable to provide documentary evidence of practical competence, we can provide an assessment inspection visit by one of our trained Professional Standards Inspectors. We charge a nominal £75 (non-refundable) fee to contribute towards the cost of this service.

### *CIPHE Business Directory Premium Listing*

If you are an Associate, Member or Fellow and are self-employed, for a small additional fee of £50.00 + VAT, you can choose to have your details promoted at the top of the Business Directory Listing on the CIPHE website.

Entries are restricted to those members operating an installation and repair service to the public basis who wish to identify their services for the public benefit.

### *Registered Plumbing/ Heating Company*

If you run a business with multiple plumbing and heating professionals providing services, you can register as a Registered Plumbing/ Heating Company to promote that your whole business operates at the high standards expected of a Professional Body.

There is a flat fee of £250 +VAT to register your company, with the additional membership fees applicable for individuals at a ratio of:

- 1: 5 for up to 50 operatives
- 1:10 for up to 100 operatives
- 1: 15 for 101 operatives or more

**Example:** Smith and Jones Plumbing Company has 35 members of its team delivering engineering services. The cost associated with this would be:

RP/HCo: £300 inc. VAT

Business Directory listing: £60 inc. VAT

Individual memberships (7 individuals): £1,029

Total: £1,389 (£60 of which is VAT)
